CONDITIONS AND REGULATIONS:

1. Entries must be the sole work of the entrant and is open to NZSAG members only.
2. Entry forms signed and submitted with appropriate entry fees signify acceptance of all conditions of entry and sent separately from the artworks, and received by **July 10, 2015**.
3. The entry fee is non-refundable. If paying by cheque, entry payments must be made payable to NZSAG.
4. All entries must be for sale. **Price must include 30% for commission and GST even if you are not registered for GST.**
5. GST on all artists portion of the sale price is the responsibility of the artist.
6. All works will remain on display for the duration of the Exhibition.
7. All forms of Glass Art are acceptable, but glass must be the main component.
8. NZSAG reserves the right to disqualify any entry damaged, sub-standard or deemed in any way inappropriate.
9. Each entry must be clearly identified with the title and artist's name.
10. Entries must weigh no more than 25kg.
11. Hanging pieces should be discussed with the convenors prior to submission.
12. Insurance for the artwork is the responsibility of the artist.
13. Courier costs are the responsibility of the artist. Hand delivery to Sauvarins, is open from Wed, July 22 to Friday, July 24 by 5pm.
14. Unsold work may be picked up from Sauvarins on **August 5, 2015**. Artists **MUST** supply return courier tickets for any unsold work that is to be returned by courier.
